During Trish's tenure, her passion for the mission of empowering children and adults with developmental disabilities to advance their productivity, independence and inclusion in the community has been evident throughout. She served on various local, state, and national boards/committees including the Board of Directors of the National UCP organization, the Ohio Provider Resource Association, and the Developmental Disabilities Provider Consortium while also serving on the steering committee of the Developmental Disabilities Practice Based Research Network. She successfully facilitated the growth of the UCP Board of Directors that led to its current state of high engagement and support.

Beth holds a Bachelor of Arts in Sociology from Baldwin Wallace University and a Master of Nonprofit Administration from John Carroll University. Her extreme levels of dedication and passion for our mission along with her institutional knowledge – both programmatic and administrative – qualified her as the ideal candidate. The Agency finds itself at a unique point in its evolution as it recovers from the strains of the pandemic, and the organization is fortunate that Beth is willing to guide its direction beginning in 2022. The Agency will be in very capable hands.

Trish and Beth will continue to work closely for the remainder of the year, as they always have, with special focus on the transitioning of CEO duties.
