2014 Director's Task Force on Oral Health and Access to Dental Care

We want to hear from you.

Mr. Lance D. Himes, Interim Director of the Ohio Department of Health (ODH), has convened the 2014 Task Force on Oral Health and Access to Dental Care to make recommendations on how to increase statewide access to oral health and prevention services. In April and May, ODH will hold regional meetings in five locations to get input from consumers, providers of health care and others interested in improving access to dental care.

Each day there will be two sessions, one in the morning and another in the afternoon. Morning sessions will focus on the needs and challenges facing patients/consumers of dental services. Afternoon sessions will focus on the needs and challenges of providers, such as dentists, physicians, nurses, etc. Participants may attend one or both sessions.

A facilitator will lead each group through a series of questions and an open discussion. We are particularly interested in knowing more about the barriers that keep people from getting the dental care they need and ideas for how to improve access to dental care in Ohio.
