I would like to kick off the year with a few reminders and requests for feedback:

- Please remember to keep your personal property put away while at work. This may include bags, keys or other items; it is easy for things to become lost or even confused by others.  - Brunch with Beth will continue monthly (where team members are chosen at random to meet with me and individuals from different departments to discuss topics of interest).
